Below is an extract of the proceeding of the 28th Meeting of the Senate held on 6th June 2020

***ITEM NO. 4(a) TO CONSIDER REVISION IN FIRST STATUTES REGARDING ELECTION TO SENATE, SYNDICATE AND REGISTERED GRADUATES, 1978 (AS AMENDED)**

This item was presented by Prof. Dr. Muhammad Tufail, Pro Vice Chancellor. While presenting the item, he provided the rationale for the proposed amendment in the Statutes and requested the August House for approving the same

Engr. Sohail Bashir opined that the changes in the Statutes regarding Registered Graduates had rightly and timely been proposed and it might be approved which was seconded by Engr. Farhat Adil, after which, the following resolution was passed:

RESOLUTION NO.SNT-28.4(a)

Resolved that the following revision in First Statutes regarding election to Senate, Syndicate and Registered Graduates, 1978 (as amended), stands approved:

EXISTING	APPROVED
"Registered graduates" means a graduate of the University whose name has been entered in the register maintained for this purpose and includes a graduate of any recognized University, in any of the subjects prescribed by or under the Act and residing within the local limits of the division of Karachi, and whose name has been entered in the said register.	"Registered graduates" means a graduate who had studied at NED Engineering College or the NED University and completed their degree, and whose name has been entered in the register maintained for this purpose.

It was further resolved that the names of such graduates who had not studied at NED Engineering College or NED University for deletion from Graduate Register, stands approved."

Copy is forwarded for information and further necessary action under intimation to this office so that the same are reported to the Senate in its next meeting. In case there is no action to be taken a report to this effect may kindly be furnished.
